Arts In Reach (AIR) has been awarded tax credits through New Hampshire's Community Development Finance Authority's (CDFA) highly competitive program to support a new two-story community center in Durham, NH. This dedicated programming facility will allow AIR to expand its impact on New Hampshire's youth, addressing the urgent teen mental health crisis that has only intensified since COVID.

The new facility will replace AIR's current "floating" model, where finding accessible, affordable spaces has become increasingly challenging and inefficient. This new building will provide teens with a stable, trauma-informed space to engage in creative expression, self-discovery, and community. With a permanent home, AIR can increase opportunities for teens to participate in life-changing programs, scaling from 300 to 1,200 annual spots and enhancing safety, security, and consistency for youth and families alike.

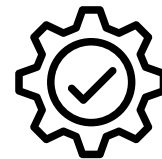
HOW CDFA'S TAX CREDIT PROGRAM WORKS FOR YOU



75% Tax Credit:
